As the Committee members are required to consider and respond to Planning Applications within a fixed time period, generally little more than 14 days from receipt by the chairman, applications and matters of a time critical nature that arrived after the issue of the agenda were considered at this meeting.

a) S/1479/13/FL. Erection of 12 bed inpatient ward and ancillary accommodation. Location: Papworth Hospital. Applicant: Mr G Marinelli, Papworth Hospital NHS Foundation Trust. (Dated 26 July 2013). Recommendation: Refusal.

b) S/1483/13/CA. Demolition of ambulance canopy and fuel tank and base. Location: Papworth Hospital. Applicant: Mr G Marinelli, Papworth Hospital NHS Foundation Trust. (Dated 26 July 2013). Recommendation: Approval.

c) S/0623/13/FL. Outline planning permission for the demolition of existing buildings & the erection of up to 58 dwellings (class C3), car parking & associated works etc. Location: Land between Church Lane & Ermine Street South. Applicant: Mr I Baggaley, Learig Ltd. (dated 26 July 2013). Recommendation: Refusal.

d) S/1480/13/FL. Resurfacing of land and temporary use for hospital parking purposes until April 2017. Land at junction with Elm Way, Ermine Street North. Applicant: Mr G Marinelli, Papworth Hospital. (dated 30 July 2013). Recommendation: Refusal.

e) S/1523/13/VC. Variation of condition 22 (approved plans) of planning application S/1424/08/RM for 81 dwellings. Location: Land to the South, Southbrook Field. Applicant: Barratt Homes. (dated 1 August 2013). Recommendation: Refusal.
