FCHR 10/09-20 To review the income/expenditure of financial year 2020-21 to date.

The income and expenditure year to date was reviewed.

The Clerk confirmed that furlough payments continue to be received from HMRC to

cover part payment of the caretaker's salary as per the scheme details.

There were no queries raised.

FCHR 11/09-20 To review the updated NALC pay spines and approve an increase to the salary

of the Clerk and Assistant Clerk in line with the nationally approved pay scales

for April 2020- March 2021

(PC declared a pecuniary interest in this item and took no part in the discussion for

this agenda item)

The NALC national pay scales for 2020/21 were approved & issued 26 August 2020 -

to be backdated to 1 April 2020.

It was resolved to submit a recommendation to the Parish Council to approve an increase to the Clerk and Assistant Clerk's pay rates in line with the NALC pay scales and back date to 1 April 2020 (Proposed PP, Seconded VC, Agreed All. PC did not

vote). The new salary rates proposed would be :

Clerk: NALC pay scale SCP 24 £14.90ph - min of 110 hours pcm

Asst Clerk: NALC pay scale SCP 12 £11.53ph – 10 hours pcm

FCHR 12/09-20 To review the hourly pay rate for the Bookings Clerk and Caretaker

The hourly pay rates for the Bookings Clerk and Caretaker were reviewed.

It was resolved to submit a recommendation to the Parish Council for approval to align the salaries of the Bookings Clerk and Caretaker to the published NALC Scales for non-clerking staff (Bookings Clerk aligned to SCP4, Caretaker aligned to SCP 1), and to backdate to these increases to 1 April 2020 and review annually in line with

the NALC issued pay scales (Proposed VC, Seconded CH, Agreed All)

The new salary rates proposed therefore would be:

Bookings Clerk: £9.84 per hour – as required to undertake the work – min 20hrs pcm Caretaker: £9.27 per hour – 26 hours per week (paid in equal monthly payments)
